SPECIFICATIONS AND INSTRUCTIONS TO BIDDERS FOR READY MIXED CONCRETE – June 1, 2022 thru May 31, 2023

GENERAL: This specification for which bids are invited covers the furnishing of accurately proportioned ready mixed concrete to the site of the work, including aggregate, cement, water, labor and plant equipment to properly manufacture the concrete, and transportation to the points required.

BATCHING OF CONCRETE: Aggregates and bulk cement shall be measured to within one percent (1%) by weight. Cement in standard 94# sacks need not be weighed. Water shall be measured by volume or weight to within one percent. (1%)

The complete batching plant assembly shall conform to the following requirements: Ready adjustment of aggregate weights for varying moisture contents: proportion of water to cement accurately controlled and easily checked: accurate control of all materials with positive shut-off: facilities for prompt removal of excess materials in hoppers: visible dial of balance indicators: each specific size of aggregate measured separately with a separate beam scale and drawn from a separate bin: bulk cement dropped through canvas chute or telescopic flexible hose, six 50 lb. weights provided. When checked in increments of 500 lbs. the weighing apparatus shall be accurate within 0.004 to and including the heaviest batch weight expected.

The equipment used in weighing each mix of batch shall have been tested by a commercial testing plant or inspector, which is approved by the Village Public Works Construction & Maintenance Supervisor, Department of Public Works, and may be rejected if it is apparent said batch does not meet the specifications.

Aggregates Cement shall be Portland Cement of 1-A, or for ready mixed concrete. Course and fine aggregates shall conform generally to the requirements of the New York State Department of Transportation of current modification as to quality and sized. All aggregates shall be crushed gravel, crusher must be crushing at all times, properly screened for sizing: and then recombined accurately by weight. All crushed gravel shall be 75% fractured. Storage pile of each aggregate shall be kept on hand (unmixed) sufficient to mix and deliver 200 cubic yards of concrete on four hours' notice within the township of Malone in order that no delay may occur. Such delivery to be made when required within an eight-hour day. Bidder shall state whether or not he is willing to guarantee this delivery. Storage shall be available for inspection any working day.

CONCRETE PROPORTIONS:

All concrete shall be machine mixed for at least one minute.

These proportions may be altered as required by the foreman on the job. Bids shall be submitted as follows, based upon prices of cement, future changes in said price to compensate for by adjusting price.

- 1. Bid per cubic yard of mixed concrete for a "5 Bag Mix" (94# of cement per bag) as delivered within the Village of Malone.
- 2. Bid per cubic yard of mixed concrete for a "6 Bag Mix" (94# of cement per bag) as delivered within the Village of Malone.

Bidder shall state approximate amount of concrete that can be delivered in an eight (8) hour day.

TESTING: Concrete is to be tested, at the expense of the bidder, prior to acceptance of the bid.
