## WATER SUPPLY RULES

- A. The Department of Public Works representatives shall have access at all reasonable hours to all parts of the premises to which water is supplied.
- B. The Department of Public Works reserves the right at any time, without notice, to terminate the flow of water in any of its mains in cases of conflagration, to make necessary repairs and extensions, and for such other purposes as become necessary or desirable.

<u>CAUTION</u>: All consumers having boilers within their premises not supplied by tanks or cisterns and depending upon the pressure in the pipes to keep them supplied are hereby cautioned against the danger of collapse. Risk of danger, in all cases, rests exclusively with, and is accepted by, the consumer. In cases of danger the hot water faucet should be opened.

C. The Department of Public Works undertakes only to use all reasonable care and diligence to provide a constant supply of water through its mains to consumers. The <u>VILLAGE OF MALONE</u> shall not be liable to any consumer for damages resulting from the public enemy, the elements, or any accident, misfortune, failure or break in the reservoir of mains of the <u>VILLAGE OF MALONE</u> .		
D. All faucets and valves shall be kept in such a state of repair as to ensure that there shall be no waste of water.
